EDITORIAL

During the last decade of the 20th century the increase in deliveries of premature babies at HFH and the high mortality rate of these tiny babies obliged the Board of Trustees of Holy Family Hospital to contemplate seriously the opening of a Neonatal Intensive Care Unit in spite of the disastrous political and economic situation which prevailed in this country at that time and especially in the following years. In 2005 due to an occupancy rate of 120 %, obliging us to put sometimes two premature babies in the same incubator, we urgently had to increase the capacity of our Intensive Care Unit.

During that difficult period, however, we were never pessimistic for a moment, in spite of all difficulties the mothers had to face before reaching our hospital due to numerous checkpoints and in spite of the huge financial resources we had to secure to expand our NICU: had we been pessimistic then, we would have lost even before we starting.

Since this Unit was opened, Holy Family Hospital has continued to consolidate its position as the major provider of maternal and newborn healthcare in the District of Bethlehem. From its share of 37% of the total deliveries of the district in 2002, the activity rose to 67% in 2007 (according to the statistics of the Palestinian Ministry of Health). In spite of the increasing of beds in the neonatal department from 10 to 18 beds in 2007, the occupancy rate increased from 47% in 2007 to 96% this year as in fact we were becoming the regional Neonatal Intensive Care Unit. We are attracting more and more premature babies born outside of our hospital and even outside the District of Bethlehem(22,6% of all babies admitted to this unit in 2008). This represented an investment of a huge amount of money for adequate equipment and training of our staff while the running costs are mostly uncovered because of a lack of social security in the West Bank.

We are highly concerned about what is going on around us, thinking about others and those desperate for help, such as the tiniest and defenseless babies living in this country. Helping others is always paramount in our life and the mission of the Knights of the Sovereign Order of Malta. While, following the teachings of the Catholic Church we don't accept to practice in vitro fertilization, we are regularly confronted with mothers with multiple pregnancy who desperately are looking for a safe place to deliver when other hospitals refuse to take them because of lack of qualified staff to deal with high prematurity and because of the huge financial consequences of hospitalization of premature babies of such a multiple birth (about 400USD per baby per day).

In this country everybody knows that at Holy Family Hospital "there is always a place in the inn for all" .We never reject a mother who is in distress.

Nevertheless, it is our duty to promote creating Neonatal Intensive Care units in other hospitals in the West Bank; our financial means and the number of intensive beds in our neonatology unit are limited and already constitute the utmost that we can afford.


