Mr. Dominique De La Rochefoucauld-Montbel attended the presentations that were prepared by the bidders who participated in the bid announced on June 2013 related to the selection of an Architect/Engineering Firm. Five bidders participated in this competition. After a detailed examination of all the work submitted; the committee decided to retain the two best bidders in order to participate in Phase II Competition. All committee members are now working together in preparing a full detailed program that will include a set of detailed requirements related to the needed equipment, mechanical and civil works...etc that will be the base for Phase II competition. It is estimated that by the beginning of November 2013 all the required documentation will be ready and estimation for the total cost of this project will be identified in order to be submitted to the Board of Trustees.
